

STATEMENT OF FACT FOR SENTENCING

In the pre-trial phase of this trial your Honor do you recall granting a motion for a Transcript to be prepared from a one Gary Heaths Testimony that he gave before a special Grand Jury? "Do you ever receive it?" I never.

Sir as to this same individual do you recall reading the motion Mr. Hobbs provided you with from a one Gary Heath in which he stated quote "Billy never said nothing like this to me."

Mr. Heath goes on to say of his own free will, that he was coached by a one Dave Lindloff. Who by coincidence just happens to be the Preble County Prosecutor's Investigator. I submit to you your Honor that, if you coach one person to lie, you will coach more. Namely Jason Burkhart and Tony Young. Using the Prosecutor's own words if you lie once, then you'll have to lie some more. And keep telling lies to cover up. Also your Honor if we're suppose to be Honest in Court Proceeding "you" yourself will know this. It's on record that investigator Swihart, and Mr. Petite were both caught in lies about interrogating me. As to time. I submit to this Court your Honor from the Prosecutor's own words. Lie once lie twice.

Further "corruptness" and "dishonesty" came from Mr. Kalil Asst. Preble County Prosecutor. In which one of the States own Witnesses Mr. Don Sutton: When asked by Mr. Hobbs if Mr. Kalil during Court recess had a conversation concerning the moon conditions he stated "yes he did". Then came back in the Courtroom and knew to say yes to a moon question. Mr. Kalil is quite green at this you Honor he doesn't have the experience "yet" that Miss Ferguson has at prompting and coaching Witnesses. He did his dirty work out in the open Miss Ferguson does her's behind closed doors. As stated by the State's Key Witness, Tony Young. He spent considerable time with the Prosecutor on the Saturday before trial I submit to this Court, if you know what you Saw. And your supposedly telling the truth. Why would you spend most of Saturday morning with your witness just before trial?

Your Honor it has also been brought to my attention that the State's Key Witness Mr. Tony Young is related to the Stoner Family. Which information I might add came to us "After Trial" clearly such information if true your Honor should justify extreme prejudice and justify a new trial under newly discovered evidence. No matter what the cost.

As you know I was involved in a serious altercation with a member of the Stoner Family and other members of the Biker Group the Dayton Outlaws. Of which Ricky Lee Stoner was killed. It is also a matter of Public Record that I was found innocent of his murder by reason of Self-Defense. I submit to this Court that it is also a matter of Public Record that "After" I was found not guilty of Mr. Stoner's death vengeance set in. Miss Stoner the Mother made it very clear she wanted vengeance by instantly after the verdict taking down the names and getting the Jurors addresses. Consequently the Saturday night after the verdict, an attempt was made by a one James Ferguson to blow up Mr. Hobbs office with dynamite. Which, thank God was foiled by Miamisburg Police. This James Ferguson I might add is the same James Ferguson who was Mr. Stoner's best friend, who also was shot by me in an attempt on my fiancés life and my own. Mr. Ferguson is a carbon copy of Mr. Stoner and Mr. Ruebush they had no regard for human life. They had no idea who could or could not have been in that building if their vengeful plan had succeeded.

Your Honor, these attempts of foiled revenge leads us to another attempt which did not fail. Mr. Tony Young. Mr. Young is the step son of David Stoner. Mr. Young amazingly enough comes forward almost a year after Lisa's death just 44 days after I'm found not guilty of a member of his family's death.

How convenient for the Prosecution. I submit to this Court that Tony Young is a fraud. That Tony Young has committed Perjury. That Tony Young testimony was fabricated, prompted, and coached, by Agents of the State of Ohio. That this was also a last attempt from the Stoner Family to get revenge on me for their Son's death. I submit to this

Court that this case was recklessly put together by the Stoner Family, the Buckley Family, and the Ring Leader Rebecca Ferguson. For Miss Ferguson it was done for Political reasons. She will be running for election at the end of this year. For Tony Young and the Stoner Family this was their sneaky way for revenge. A non-Explosive piece of human dynamite. Which is consistent with their previous actions. I would also add to this that a partial transcript has been put in with my motion for new trial. It is a transcript of a taped statement from Tony Young taken by an investigator of which Rebecca Ferguson was present. When Mr. Young was asked where he lived Miss Ferguson with a quickness objected to it. Stating quote "I have a problem with his address being released". The investigator went on to ask how long have you lived in the area. Again I'm going to object Miss Ferguson said to that question. I submit to this Court that Rebecca Ferguson knew first hand that if Tony Young's address was released, that my Attorney would of found out. And put it together that Tony Young was a member of the Stoner Family and household. But we had no idea. Cause it was purposely concealed from my legal team and myself. It's in black and white on tape. "No" other witness in the case had the benefit of Miss Ferguson's presence during questioning. "What" was she scared of or hiding? I submit to this Court again that Miss Ferguson's presence and concealment of his residence proves deception and coercion of a State Witness in a homicide investigation which is a felony. It is very clear that Miss Ferguson is guilty of using perjured testimony and this Court would reach a new height in ignorance if it was to believe otherwise. At different times in trial a Mr. Tom Riley told this Court. Mr. Swihart wanted Kevin Gray to lie and go along with Jason Burkhart's story. Gary Worley stated under oath that Mr. Swihart wanted them to lie and say they saw the murder in exchange charges would be dropped on Kevin Gray. Gray said it "never" happened they saw no such thing. His statement was put into evidence. Unfortunately Kevin Gray could not be found by my investigators, he went into hiding. For the simple fact that he wouldn't lie for the State. They never dropped the charges. And Kevin Gray knew he would be arrested as soon as he stepped foot in this Courtroom to tell the truth.

Unfortunately Gary Heath was never used in this case and he also was a key witness For the State. And was also the key to getting me indicted. Surely you would use a witness who helped indict a person. But the State didn't. And with good reason. He came forward with the truth this time and that's what the State could care less about-is the truth. He was subpoenaed by the State. That is on record. It is also a matter of record he was dropped by the State just before trial. When my Attorney supplied the State and This Court with a copy of Gary Heath's handwritten and signed testimony that he was made, and took a very nice deal offered by Rebecca Ferguson and Dave Lindloff. However he had a conscience and it bother him. And He came forward with the truth this time. Now we have not one, not two, but three strikes against the State by their own Witnesses that, they were coached, prompted, or attempted to get a witness to lie. In a ballgame 3 strikes puts you out of the game. But it didn't stop there a fourth strike was had and this time by a member of the Buckley Family to get Roy K. Smith to accept \$10,000 to purchase a witness testimony. He hem hawed around at first but finally says yes-an offer was mad of \$10,000. A taped conversation was mad between both investigators. Unfortunately, it was not admitted into evidence or this Court would of heard Mr. Smith say he told Miss Buckley, he could not do that, it was against the law. A reward to be given is not against the law, to my knowledge. So what was he speaking of that was, speaking of \$10,000? Miss Buckley had "no" idea why I had her subpoenaed but she knew to bring a bank statement from the Buckley's Fund money which we did not request. I submit to this Court she knew she had been reported by Mr. Smith. Cause Rebecca Ferguson had the police go to his residence to make him call her to tell her what he was coming to testify to. Which he did tell her. And Rebecca Ferguson had Miss Buckley bring in those bank statements to purposely Show she didn't have but approximately \$6000 and couldn't possibly offer \$10,000- yet a reward for \$10,000 was offered for the arrest and conviction of the person or persons responsible for Lesa's death.

Well, if you don't have \$10,000 for a bribe, how can you have \$10,000 for a reward. I submit to this Court that if you don't have \$10,000 to give you don't offer it-or you commit fraud or lie. As stated by the Prosecutor "lie once, lie twice to cover-up". It is very clear through the evidence, that the Stoner Family, the Buckley Family, and the Agents of the State of Ohio, created a murderous story over a two year period. With Rebecca Ferguson and her corrupt puppets offering charges to be dropped, and money offered. She led a bandwagon of liars through this political event-to follow the yellow brick road to convict Billy Scott of murdering Lesa Buckley.

They came at me your Honor with a vengeance and a total disregard for written law. When it came to the Scotts it was open season. And it is clear by the foul ups and holes in this fabricated case, that it will be overturned on Appeal. You got Round One. But, Round Two is mine. And I will be back. I will take this Statement to my grave and that is: I had absolutely nothing to do with Lesa's death and had no reason to kill her whatsoever. We were and are still good friends-my brother and myself have only protected her.

A member of the Buckley Family made a statement to the press after the verdict that Rebecca Ferguson set his heart at ease. I submit to you today in this Courtroom-Mr. Buckley, now is the wrong time for your heart to be at ease. You helped convict the wrong man. And Ronnie Johnson is free and laughing at both of us.
