

To Whom it May Concern

On March 20, 1991. My daughter Alicia Heath, was stabbed in the right side of her neck. Very near the Carotid Artery. ~~By a person~~ ~~at the time~~. She was taken to Mc Cullough Hyde Hospital. There she gave a statement that Gary Heath had stabbed her. She didn't know what with. While being treated. Gary called 911 Dayton. Told them he had just stabbed his wife and wanted to turn his self in. When Preble County officers pick him up. He told them Alicia accidently stabbed herself with a pair of sissors

Preble County officer inform Mc Cullough Hyde Hospital that Gary said the weapon was a pair of sissors. The weapon and Alicia purse disappear from her car which Gary escape in after the stabbing. Later purse was found an turn in to Preble County Police 1 hr. before court. Preble County had tape from 911 of Gary admitting stabbing Alicia. He was put in jail

March 20, 1991 Around 10:00 - 11:00 PM.

Alicia was transfer by Air-Care to University Hospital in Cincinnati

Doctor at McCullough Hdyr Hospital didn't know how serious her condition was how deep the wound for sure

She was keep over night and discharged evening of March 21, 1991.

I called Eaton Police to make sure Gary was charged. And to see if they need to come take a statement from Alicia. I was told no she had plenty of time 72 hrs. That he would not be turn lose. When

Mc and Boyd got Alicia to our house evening of March 21, 1991. I called

Jerry Deaith. Told him Alicia was here want him to come take her statement. He said he be down in morning of March 22, 1991 to get it.

There was no hurry. That Gary wasn't going any where. At that time Jerry Deaith was the police Chief of Camden. Where the stabbing occur.

Eaton release Gary morning of March 22, 1991. Knowing that Alicia

was on her way up there to give statement to what happened. They even took Gary to Butler County line and turn him loose. We were told they had to release him because Alicia hadn't made a statement. It had only been less than 42 hours. And besides that Gary was on Parole. And his Parole officer Tony Caliber was never notified of Gary's actions. Me and Alicia when to Dayton, told Tony Caliber about what happened.

He said he put a hold on Gary as soon as he was picked back up.

And he did. There was also a parole Board investigation during all of this officer out of Cincinnati.

After Alicia gave her statement to Eaton, David Lindloff told me and Alicia. He called Gary at his sister in Hamilton Ohio. Told him a warrant had been issued for his arrest he gave Gary until 6:00 PM March 22, 1991 to turn himself in. He said Gary said he'd be in by 6:00 PM.

I can't ~~believe~~ this is the way
a law officer is to do their job.

David Lindloff just lean back in
his chair Made the statement to me
and Alicia. That if Gary decided to
run he hoped it was soon where
warm. He need a vacation. Gary
was on run for as we know he
never left Hamilton. He was seen
and spoken to by family members that
live in Hamilton. Who called me
and told me about seeing and talking
to him. I got mad one day and
when to Hamilton. I walk in to
Sheffer Hozeteger office and ask
Sheffer Hozeteger why Gary Heath
was walking all over town day and
night. When Preble County had a warrant
for him and Butler County was notify
to pick him up. Sheffer Hozeteger got
very upset. Started checking in on
what I was telling him. Alicia had
received 4 or 5 threatening letter from
Gary threatening her and family. I
even called FBI talk to Jennifer Linsey
I believe was her name. She was very

upset. ~~What~~ ~~with~~ With the way
Preble County was handling this case.

And she also talked to Jerry Death.

Sheffer Hozeberger told me he
had no knowledge about Gary and
his office had not been notify. He
called his head detective in his office

His first name was Jerry can't
remember his last name. Jerry ask
if this was the same Gary Heath
that had been in trouble before he
know him. And had deal with him
before. I found out Gary had been
question in a murder of a girl in Muskegon
Ohio back 1985 or 86. Jerry ~~start~~ started
looking for Gary right away. That
evening I got a phone call that Gary
was in a Motel on Rt 4 out of Hamilton
and his room Number. I call Detective
Jerry? and told him. He arrested
Gary within 30 minutes after I call
he was there. And they turn him
over to Preble County law officers. Gary
was behind bar finally. We were so relieved

Gary was charged with felonious Assault
by a Grand Jury. filed April 9, 1991.

(and arrest)
 The day after his indictment Gary
 ask to talk to David Lindloff. David
 Lindloff told me, Alicia and her father
 Boyd. He was going to talk to Gary

That Gary want to make a statement
 And that he call us soon as he was
 done talking to Gary.

David Lindloff called me later
 at home. Very upset. He said Gary
 had give him a 20 page statement
 and he had in on tape. That Gary
 was worried about Alicia. That he
 was involved in a murder of a girl
 in Mason Ohio give dates, names of
 who was involved complete details
 of how she was killed. Dave this
 in detail that only some one involved
 would know. and that Gary had helped
 dispose of her body. David Lindloff said
 the men he named was very dangerous
 he know of them. He said Gary told
 him he called these men and told
 them to get Alicia. That Alicia know
 everything. Alicia only know a little
 about the girl. Alicia said Gary had
 threat her before with this. David

ask us to get Alicia out of the State as quick as we could. That night if possible. And not let any one know where she was. This was what all the threatening letters was about. These statement is suppose to be in file (Case No. 91-CR-6841)

Will while waiting trial. Billy Scott was locked up with Gary. I can't remember dates so this give you idea when this was going on.

Brent Copeland (Assistant Prosecuting Attorney) Called wanting to talk to Alicia. I took her to his office Mr. Copeland told Alicia and Me. Gary want to plea guilty to a lesser charge of Assault and Aggravated Menacing. And wanted to know how she felt about it. He said Gary would get just about as much time on these two charges as on felonious Assault charge plus serving time for Parole violation and the time he waited for trial ~~was~~ would not count on his sentence. Which was 81 days. And He could ~~see~~ see any way Gary would get visitation to Jake (Gary Gary old son). Alicia told

him she'd like to stay with the falsified assault charge. Brent told Alicia that without the weapon it would be hard to win. He then told us the decision was his to make that it didn't matter what she wanted to do. He walk out of his office and told Gary attorney he let him plea guilty to Assault and Aggravated Menacing. I'm sending you copies of what Gary was sentence too.

And there was nothing ever told on Parole violation charge. I was never able to find anything out on it. Or anything out on Gary statement about the girl that was killed.

Gary was sentence on Aug 2, 1991

I got a phone call from Brent Copeland and went to talk with him. Gary hadn't spent his time yet. Brent said Gary had been writing Judge ~~Ab~~ Abruzzo. Trying to get a early release. He told me Gary had wrote Judge Abruzzo threatening letter. Which was wrote in a way that they didn't seen threatening if you know what I mean. And that Judge Abruzzo

had agree to let Gary out early and a hearing was set. Can't remember the date. Me and Boyd attended the hearing. After the hearing I ask Brent Copeland about the holder the ~~Parole~~ Parole office Tony Calibi had on Gary. Because he was not given any ~~the~~ time on that. He said it was still on Gary. That Gary would not be leased unless Tony Calibi drop the holder.

Will ~~Gary~~ Gary was released that morning. And he also got visitation to Jake at the hearing.

I try to get a hold of Tony Calibi to see what was going on. Tony called me at home that evening. When I ask him why Gary's holder was drop and why he didn't get any time on the parole valuation. He told me that they were going to use Gary to put ~~and~~ Billy Scott away for murder that he was more dangerous than Gary.

And they couldn't ~~to~~ put Billy Scott away with out Gary testimony.

This is his exact words. I couldn't

believe what I was hearing.
And there wasn't a thing we could
do. Gary was release 2 or 3 weeks
before Billy Scott Trial started.

They used Gary who they
had on tape 911. Admitted stabbing
my daughter. And had on tape and
20 page statement of being involved
in kill another girl in Mason.

Knowing how dangerous Gary is. And
what he is capable of. Let him walk
the street to do it again. And give
him visiation right too a 2 yr. old
boy and ~~one~~ put his life in danger.

Something has to be done
with the way our legal sytens
operates. All of this is the truth.
