Before I went through the gate Jesse came up to my car opened door she got in and he rode only 25 yards or so. She said she had to go see someone or there was someone she knew.

She got out and said she would see me later.

Q2 Did you see Jesse after this?

A2 No. If she was around she would have been at the party and she wasn't.

Q3 What did Jesse have on?

A3 Shorts and a top that would expose her belly.

She had arranged for Missy Longmire to meet her at the gate on Guy Murray Road to show her where the party was located. Bunna said she got to the gate at approx 2305 hours. Met Missy and they drove back to the party area. Bunna said that when she got to the gate where they were checking people. She saw Lesa, she and Lesa talked for a few seconds and then Lesa got into the car with Bunna. They parked the car, spoke for a very short time. Lesa said something about she had to see someone or was waiting for or looking for someone and she would see Bunna later. Bunna said she did not see Lesa after that.
