Q. Did Billy or Jerry say anything to you after they found Jess

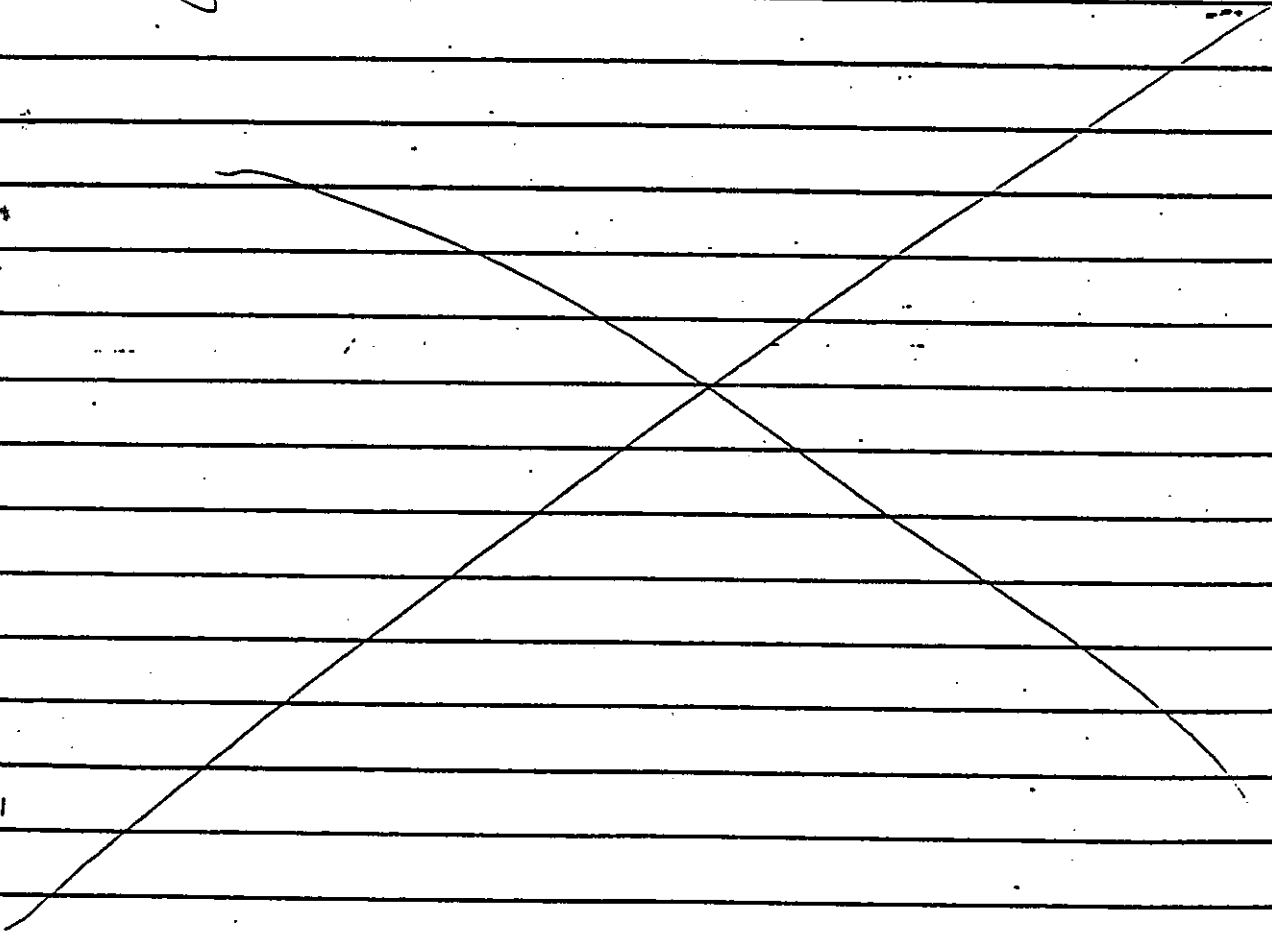
A. Not anything other than call the police
